3. ELIGIBILITY CONDITIONS:

Upper Age Limit: 45 years (age as on crucial date)

- **For Non-Medical Candidate (M.Sc. with Ph.D.):** - Level-10 in pay matrix with a minimum of Rs. 56,100/- and admissible allowances as applicable to Govt. of India employees stationed at Bilaspur H.P. NPA will not be paid as applicable to medical graduates.

5. **TENURE:**

The tenure of the post shall be of three years, provided the overall past residency period of the candidate in AIIMS Bilaspur or other institute do not exceed three years. Accordingly, the candidate shall declare his previous details of senior residency in the application form under '**Professional Experience**' (Point No. 18).

6. **SELECTION PROCEDURE:**

- Walk-in-Interview will be held at Administrative Block, 3rd Floor, AIIMS-Bilaspur, Kothipura, Himachal Pradesh-174037. **Candidates are required to report on or before 09:00 AM on 10th, June 2026.**
- Candidates are not required to fill any online form. Interested candidates are advised to report in person at the Recruitment Cell, 3rd Floor, Administrative Block, AIIMS Bilaspur, Himachal Pradesh, on or before 09:00 AM on 10th, June, 2026.**
- Candidates will have to appear physically before the interview board.** No request for an online interview will be entertained.

7. **RESERVATION CRITERIA:**

- The reservation for **OBC/EWS/SC/ST** candidate is as per Central Govt. rules and 04% for PwBD candidates (on horizontal basis).
- For OBC Candidate:** Candidates must attach certificate issued by the competent authority valid for the posts under the Central Government of India clearly indicating that the candidate does not belong to Creamy Layer. As the vacancies are advertised in the financial year 2026-27. **Therefore, the certificate of OBC-NCL category issued on or after 01.04.2026 will only be considered valid.**
- Economically Weaker Section (EWS):** Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below ₹ 8 lakh (Rupees eight lakh only) are to be identified as EWS for benefit of reservation. Income shall also include income from all sources i.e., salary, agriculture, business, profession, etc. *for the financial year prior to the year of application.* Such candidates should have valid income certificate on the date of application in the prescribed format or on the letter head of the issuing authority to this effect before filling the application and submit the same at the time of document verification, failing which their candidature will be rejected. 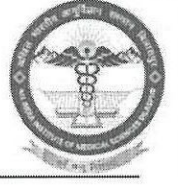
