The candidates applying on deputation should be serving in institutions/organisations of comparable nature and standing, as per the eligibility criteria prescribed for the respective positions in the advertisement. The deputation tenure shall ordinarily be for a minimum period of three years, and applications must be forwarded through the proper channel.

Candidates are expected to engage in high-quality research, contribute meaningfully to our growing undergraduate, post-graduate, and doctoral programs, actively participate in institutional development, and strengthen the Institute's engagement with academia, industry, and society. Applicants should have a strong academic background, effective communication skills, a demonstrated or potential ability to conduct original research, and a commitment to excellence in teaching and institutional service.

- Excellent academic credentials with First Class (Min 60%) or equivalent grades in Master's and Bachelor's degrees with a consistently good academic record.
- The candidate for the rank of Full Professor must have an excellent teaching record of research in the form of publications in reputed and highly ranked international peer-reviewed journals.
- They should have administrative, consulting, and executive education teaching experience commensurate with their rank and experience.
- The institute reserves the right to decide the academic/ publication/work experience parameters as criteria for optimizing the application pool.
- If the candidate's professional credentials are excellent, however, short on either of the expectations of teaching, research, executive education, or consultancy, he/she may be considered for a contractual appointment.

## **Assistant Professor, Grade II**

### **Academic Level 10**

- Ph.D. from a recognized institute/university, with less than 1 year of post-Ph.D. teaching/research experience or a provisional Ph.D. degree is awarded. Doctoral students who will not receive their Ph.D. provisional certificates, latest by the time these applications close, NEED NOT apply.
- Excellent academic credentials with First Class (Min 60%) or equivalent percentage/grade in Master's and Bachelor's degrees with a consistently good academic record.
- The candidate for the rank of Assistant Professor (grade II) must have the potential to teach across programs and the potential to publish research in reputed and highly ranked international peer-reviewed journals.
- They should be willing to undertake responsibilities across administrative, consulting, and executive education teaching portfolios.
- The institute reserves the right to decide the academic/ publication/work experience parameters as criteria for optimizing the application pool.

## **Professor/Associate Professor of Practice**

- Have a demonstrated understanding of practice and a passion to teach full-time in our degree-granting, duration, and long-duration certificate programs.

- Have made exceptional contributions either through unique expertise (not available internally) or through outstanding teaching quality and service potential.

- Initial term of one/two years, renewable up to five years, on an annual basis, based on performance and director's approval.
- Based on relevant experience, candidates will be designated as either Associate Professor of Practice or Professor of Practice.
- Compensation will be equivalent to that of regular Associate or Full Professors.

## Pay & Allowances

1. Pay and allowances shall be as per the 7<sup>th</sup> CPC and IIM Amritsar regulations.

## General Information

- Faculty members are eligible to apply for a seed grant of up to INR 5 lakh to support their research activities as per the extant institute policy.
- Faculty members are entitled to a Faculty Development Allowance (FDA) of up to INR 1.5 lakh per year. This allowance supports attendance at national and international conferences and the procurement of academic and research-related resources as per the admissible policies.
- The Institute actively promotes faculty engagement with industry and collaboration with other research and professional institutions. Consultancy activities are encouraged, supported by liberal consultancy policies.
- The Institute's library is well-equipped, offering an extensive collection of books, journals, reports, e-books, and access to a wide range of academic databases.
- Faculty housing is in the final stages of construction.

4. Only the applicants who are shortlisted by the screening committee will be contacted for the research seminar and interview. In addition to the academic credentials, the screening committee shall consider the teaching, research, and administrative performance, service to the profession, and institute's teaching and research needs.

## Other Terms & Conditions

2. The Institute reserves the right not to fill up any / some / all position(s).

4. Candidates who are awaiting their degree may also be considered, subject to their completion of the degree before joining the position. Duration of Ph.D. and academic experience acquired before and during Ph.D. will not be counted for the purpose of experience, except in the case of a Professor of Practice position.
5. Mere fulfilment of minimum eligibility criteria does not entitle a candidate to be short-listed.
6. The Institute reserves the right to restrict the number of candidates to be called for the selection process to a reasonable number based on relevant criteria suitable for the position being filled.
