1. The reservation for DIVYANG (PWD) (OL) candidates shall be as per rules on horizontal basis.

2 The application fee is Rs.2000/- for General & OBC (Delhi) category candidates and Rs. 1000/- for SC/ST candidates is payable in the form of Demand Draft in favour of Director, CNBC payable at Delhi/New Delhi No fee is payable for DIVYANG candidates. The application fee is non refundable.

3. The complete prescribed applications along with Demand Draft (in original), self attested copies of all certificates should reach in the Office of Director, Chacha Nehru Bal Chikitsalaya, Geeta Colony, Delhi-110031 by post or by hand **on or before 27.06.2026 till 04.00 p.m. In case the last date of submission of applications is a holiday, next working day would be treated as the last date. The applications received after the prescribed date shall not be consider.**

4. Competent Authority reserves the all right to alter the number of posts at any stage. All the recruitment process would be subject to approval of Governing Council of the hospital.

5. The list of eligible candidates, schedule of interview and corrigendum, if any, will be published only on the website of the hospital. No separate call letters will be issued for interviews.
6. Applications lacking complete information as per the proforma or those that are received after the stipulated date & time and non-remittance of requisite application fee as well as failure in submission of copies of relevant documents will be liable to be rejected without any communication.
7. The hospital is not responsible for any postal delay.
8. Candidates presently working on regular/contract/ad-hoc basis or any other basis should enclose 'No Objection Certificate' from their present employer.
9. In case of large number of applications, the Administration reserves the right to shortlist the candidates on the basis of experience and qualifications.
10. Candidate should be registered with Medical Council of India /State Medical Council. After selection to the post, the registration with DMC shall be mandatory.
11. Candidates who have applied for the faculty posts and found eligible for interview should report one hour before the time of interview. The list of eligible candidates and interview timing shall be published on the hospital website only.
12. No TA/DA shall be paid for appearing in the interview.

**Terms and Conditions:**

1. The appointment of faculty shall be initially on a contract for a period of 05 years with a notice period of 3 months from either side for severance of the contract. Further extension will be based on annual performance appraisal report, Vigilance, Integrity and publication of at least 2 papers in indexed journals in 5 years tenure upto the age of superannuation in the Government of NCT of Delhi.
2. The appointment of medical officer shall be initially on a contract for a period of 05 years with a notice period of 3 months from either side for severance of the contract. Further extension will be based on Annual Performance Report, Vigilance, Integrity and Work & Conduct Report upto the age of superannuation in the Government of NCT of Delhi.
3. The candidates while appearing for interview will produce all relevant original documents along with one number of self attested photocopies of all testimonial / certificates and one passport size photograph.
4. Per month lump sum remuneration including PF and Gratuity benefits for the various posts shall be :

**For the retired Government employees, the remuneration shall be paid after deduction of Pension + DA from the above mentioned remuneration.**

No other allowances or perquisite are payable over and above the consolidated remuneration specified above.

The pay structure of the Medical Officers shall be Rs. 15600-39100+5400 (GP) (Pre-revised) and Rs. 56100/-, Level 10 and Cell-01 as per 7<sup>th</sup> CPC.

5. The cut off date of age and all other qualifications i.e. experience etc. will be the last date of receipt of application.
6. Age relaxation for SC/ST/OBC/Ex-Serviceman/DIVYANG (PH) Candidates will be as per Govt. of India's rules.
7. Candidates seeking benefits of relaxation in age and fee under SC/ST/OBC categories should produce the relevant certificates (issued before the date of advertisement) issued by competent Authority. The OBC certificate should be issued by Competent Authority of GNCT of Delhi only
8. The selected candidates will have to follow hospital wide policies and will not question the same.
9. The candidates should not have been convicted by any court of law.

10. Any canvassing by or on behalf of the candidate or any outside influence in any form with regard to selection will lead to disqualification.

11. The appointment will be terminated if any declaration/information furnished is found false or any material/fact is suppressed wilfully.

12. The decision of the Chairman of the Selection board regarding selection of the candidates will be final and no representation will be entertained in this regard.

13. The Hospital reserves the right to change the number of vacancies, withdraw the process, in full or in part and also right to reject any or all applications received without assigning any reasons or giving notice etc. All the recruitment process would be subject to approval of Governing Council of the hospital.

14. The teaching faculty/medical officer will have no right to stake claim for regular appointment for the post against which they are engaged on tenure post basis.

15. In case of any dispute the legal jurisdiction will be Delhi only.

16. If no suitable candidate is found for the post of Professor (Paediatrics), the post can be filled up at one level below i.e. Associate Professor (Paediatrics) in the category advertised. The terms & conditions and the remuneration shall be paid applicable to Associate Professor (Paediatrics) only.

17. The appointment to the said post will be subject to physical fitness from the competent medical board for which he will be sent to designated medical authority by the Institution before joining the post.
